


County Demographics

Health Facts¹

- 148,011 (33%) of Santa Barbara County residents are enrolled in Medi-Cal
- 35,644 Santa Barbara County residents were enrolled through Medi-Cal Expansion
- 3% in Santa Barbara County suffer from psychological distress; mental health has been identified among the top community health need
- 19% of Santa Barbara County residents report their health status as fair or poor, similar to all Californians

Delivery of Services

Medi-Cal enrollees receive mental health and substance use services primarily through Medi-Cal Managed Care plans (MCPs) and Santa Barbara County’s Mental Health Plan (MHP). Santa Barbara’s one MCP and the county MHP provide Medi-Cal services through a coordinated system of care in which enrollees may receive a portion of their care from the MCP and other portions from the MHP depending upon their mental health and substance use care needs. *MCPs in Santa Barbara: (1) CenCal Health.*

CPEHN facilitated community dialogue meetings across 4 regions in Southern California in late 2016 (Los Angeles, San Diego, Ventura, and the Inland Empire) to identify recommendations.

<ul style="list-style-type: none"> ■ Create a workforce pipeline for jobs in the behavioral health field. ■ Using non-traditional setting as access points services and incorporating peer/ cultural brokers as part of the mental health system. ■ Engagement and collaboration with community stakeholders, churches, and schools to develop stigma reduction campaigns and programs. ■ Expand the use of the promotora model designed to fit community needs. ■ Facilitate opportunities to work with law enforcement on behavioral health issues. ■ Participate in the Drug Medi-Cal Organized Delivery System, expanding substance use treatment services for Medi-Cal enrollees. 	<ul style="list-style-type: none"> ■ Work with community organizations, clinics, and advocates to break the stigma of seeking mental health and substance use services. ■ Educate people on their rights, regardless of immigration status. ■ Encourage the use of these vital services for communities of color. ■ Educate county officials on community recommendations to improve access to services and culturally appropriate services. ■ Develop a campaign to raise awareness of mental health services covered by insurance plans.
